12 following orders in the interest of approving, promoting, and facilitating telephonic hearings
13 within the Third Judicial District.


14 **IT IS HEREBY ORDERED** that, unless otherwise ordered or prohibited by court rule,
15 telephonic participation by all parties, witnesses, and attorneys is hereby approved. Telephonic
16 participants should use the call-in numbers and access code for the courtroom and judge the
17 hearing is before, as set forth in the attachment to this order.

18 **IT IS FURTHER ORDERED** that, unless otherwise ordered, courtrooms will remain
19 open and in person participation is permitted, so long as participants can meet the guidelines for
20 courthouse entry set by court administration.. Visitors should check the Alaska Court System’s
21 website for updates. However, persons physically present in the courtroom should maintain
22 appropriate physical distance from one another and from court personnel. Please do not approach
23 the court clerk unless invited to do so. Individual judges may limit the number of court
