

1 3. All visitors to Alaska Court System facilities must wear a face covering or mask which
2 covers the person's mouth and nose unless a stated exemption applies. "Visitors" includes,
3 but is not limited to: attorneys, parties, witnesses, other participants in the proceeding,
4 persons qualifying as victims under Alaska statute, persons conducting business at a Court
5 Clerk's Office, and members of the public.

6 4. All persons attending a court proceeding in person must wear a face covering or mask that
7 covers the person's nose and mouth, including the judicial officer and in-court clerk, unless a
8 stated exemption applies. The judicial officer presiding over a court proceeding with persons
9 attending in person may authorize the removal of a face covering or mask in accordance with
10 section 5 of Chief Justice Order No. 8149.¹

12 5. Court Clerk offices in each court location shall make face coverings or masks available to
13 visitors upon request.

14 6. The following persons are exempt from the face covering or mask requirements:

15 a. Any child under two years of age;

16 b. Any individual who has a mental or physical disability that prevents the person from
17 being able to wear or remove a face covering or mask, provided the person is able to
18 maintain required social distancing while in the court facility; and

19 c. Any individual who has trouble breathing, is unable to remove a face covering or mask
20 without assistance, or has been advised by a medical professional that wearing a face

25 (d)(5): "During courtroom proceedings, the judge may authorize removal of masks or face
coverings as necessary, including for purposes of witness testimony, defendant identification, or
making an appropriate record, provided that appropriate social distancing or other protective
measures are followed."

1 covering or mask may pose an unreasonable risk to that person, provided the person is
2 able to maintain required social distancing while in the court facility.

3 7. A person who is not in compliance with the foregoing requirements, including the face
4 covering or mask requirement, will be excluded from the court facility. Judicial Service
5 Officers shall enforce the exclusion.

6 8. A person excluded from a court proceeding may participate in or otherwise attend the court
7 proceeding by teleconference, or by videoconference if reasonably available, provided that
8 the court proceeding is not a confidential proceeding that the person is not privileged to
9 attend.

10 9. The Court Clerk for each court location shall prominently place signage at that court facility
11 informing visitors of the foregoing.

12 10. The presiding judges are continuing to monitor the COVID-19 situation and additional
13 precaution orders will be issued as warranted. A presiding judge for a District may issue an
14 order for that District or any court location(s) in the District with regards to the face covering
15 or mask requirements based on the COVID-19 circumstances that then exist in the District as
16 a whole or at particular court location(s) in the District.
