The Second Judicial District Presiding Judge Administrative Order No. 19-02 establishes a process to facilitate the referral of cases to restorative justice programs in the second judicial district. The court will refer this matter to the above tribe or organization to conduct a sentencing proceeding and recommend a sentence to the court unless the prosecutor, defendant, or a victim does not consent. If the court does not receive consent, or a party objects, there is no referral from the court.
