	All pages are signed by both parties
	Both signatures are notarized on the last page of the petition within the past 60 days.
	VIN number, or license or registration number is provided for all vehicles on page 5 at section (III)(A)(3).
	If box in item #5 at the very top of page 6 at section (III)(A)(5) is checked: Noted agreement about retirement division, and Documentation of actual value of each party's retirement.
	If the parties agree to shared physical custody on page 11 at section (VIII)(3)(b), then form DR-306 must be completed and including with filing.
	Child support calculation on page 13 at section (VIII)(A)(5).
	Paid filing fee or included Request for Exemption of Fees form.
	Certificate showing compliance with parent education requirement, or waiver from custody investigator.
	COPIES of each party's most recent FEDERAL TAX RETURN <u>and</u> two most recent pay stubs.
	All questions answered on all forms.
	Included filled-out VS-401, Certificate of Dissolution form. No cross-outs or white-outs acceptable.
	Completed DR-314, Information Sheet.
	Clerk completes judicial assignment.
