

INSTRUCTIONS FOR COMPLAINT FOR DIVORCE without CHILDREN

1. What forms do I need to fill out when filing for divorce? (Use this as your checklist.)

REQUIRED

- ☐ **Complaint for Divorce Without Children**, [DR-822](https://ak-courts.info/dr822), ak-courts.info/dr822
- ☐ **Information Sheet**, [DR-314](https://ak-courts.info/314), ak-courts.info/314
- ☐ **Certificate of Divorce, Dissolution of Marriage, or Annulment**, [VS-401](https://ak-courts.info/vs401), ak-courts.info/vs401
- ☐ **Summons**, CIV-100 [Select your location from the list at ak-courts.info/civ100.]

OPTIONAL (depending on your situation)

- ☐ If you do **not** use TrueFiling: **Case Description Form**, [CIV-125S](https://ak-courts.info/civ125s), ak-courts.info/civ125s
- ☐ **Request for Exemption from Payment of Fees**, [TF-920](https://ak-courts.info/tf920), ak-courts.info/tf920

2. How do I fill out the Complaint for Divorce without Children?

The Complaint asks for information about you, your spouse, and any marital property or debt.

3. What is my case type?

When you start a case, you need to tell the court the case type.

When you start your case in TrueFiling, use the "Initiate Case" button for Domestic Relations cases. Enter:

- the location of the court you are filing in.
- for Case Type: **Divorce without Children**
- for Case Sub-Type: **Spouses without Minor children (or pregnant) do NOT agree (or are unsure) on All Issues to End Marriage**

If you do not use TrueFiling,

- fill out and file **Case Description Form**, [CIV-125S](https://ak-courts.info/civ125s), ak-courts.info/civ125s
- check the box for **Spouses without Minor children (or pregnant) do NOT agree (or are unsure) on All Issues to End Marriage**

4. How do I fill out the *Information Sheet*?

- Fill in all of the information requested in # 1, 2 and 3.
- Provide complete information for yourself and your spouse if you know it.
- Sign your name and date.

5. How do I fill out the *Summons*?

Find the CIV-100 Summons for your court location from the list at ak-courts.info/civ100.

Fill-in the blank spaces in the top half of the form, except the case number. When you file your papers, the clerk completes the lower half, and assigns your judge and case number.

6. How do I fill out the *Certificate of Divorce*?

This form goes to the Bureau of Vital Statistics after the divorce is final.

- Complete the "Parties' Information" section, boxes 9-32.
- If you are filling out by hand, use black ink and use your neatest handwriting. If you make a mistake, start over with a blank form. This form will be sent to the Health Analytics and Vital Records office after the divorce is granted, and they will not accept forms with cross-outs or other corrections on them.

- **Important:** You must submit this form to the court so that Health Analytics and Vital Records can record your divorce. If your divorce is not recorded, you may not be able to remarry, apply for a new license, or receive certain benefits.

7. What do I do with the completed forms?

File your documents. File all of your completed forms with the court. You must use the court's electronic filing platform, TrueFiling, unless you are exempt. You are exempt if one of these applies:

- You are in a jail or correctional facility.
- You have a disability under the Americans with Disabilities Act (ADA).
- You do not have safe access to a computer, internet, or email.
- You cannot access the help you need to use TrueFiling.
- You have a language barrier or are Limited English Proficient.

You do not need to prove you are exempt. If you are exempt **and** you choose not to use TrueFiling, check and sign the text box at the end of your Complaint form.

8. What happens next?

The court will set a hearing to schedule the trial date after the other side files an answer. Usually, the purposes of the hearings are to discuss the trial date and trial deadlines and determine if the parties want a formal or informal trial.
