MOTION FOR FINAL ORDER
ACCEPTING TRANSFER OF
GUARDIANSHIP/CONSERVATORSHIP
INTO ALASKA

I am the [ ] guardian [ ] conservator of the protected person named above, and I was

1. Basis for Motion.

- a. I previously filed a petition for Alaska to accept a guardianship or conservatorship from a

b. The other State has entered a final order confirming transfer to Alaska and terminating
the guardianship or conservatorship in the original State. I have attached (or previously

d. I gave notice of this motion and the request to transfer this case to all parties who are
required to be notified under the law of both the original state and Alaska. [See page 2
