# Fairbanks Veterans Court

---

## What is the Fairbanks Veterans Court?

The Fairbanks Veterans Court is a specialized court designed to facilitate the rehabilitation of eligible veterans who are charged with criminal offenses. The Court provides judicial monitoring coupled with alternative sentencing plea agreements to help eligible veterans succeed with their own rehabilitation and return to a productive and law-abiding lifestyle; thereby reducing crime and its costs to society.

## What are the objectives of the Fairbanks Veterans Court?

- Promote public safety.
- Reduce incarceration of offenders who are veterans and promote their wellbeing in the community.
- Reduce repeated contacts with the criminal justice system among our nation's veterans.
- Facilitate access to VA resources to aid the veteran with addressing problems that led to criminal justice contact.
- Promote treatment adherence for the veteran through ongoing judicial monitoring.

## Who is Eligible?

- The veteran must be eligible for VA services, as defined by federal law and confirmed by the Veterans Administration.
- The veteran has a felony, misdemeanor, PTR out of PACE, or Felony Probation and has been referred.
- The veteran has a treatment need (related to the criminal conduct charged) that the VA can address through one of its treatment programs in order to participate in the Veterans Court.
- The veteran is 18 years old or older.
- The veteran must maintain housing within the FNSB for the duration of his/her participation in the Court.
- The veteran has an offense that was less than 4 months prior to the date the FVC application was submitted, however, this may be extended upon unanimous consent of the defense, prosecution, and judge.
- The veteran has not previously participated more than once in a drug or therapeutic court.

## How do I apply for the Fairbanks Veterans Court?

*Admission into the FVC is not automatic*, but is based on state prosecutor approval and required assessments.

A veteran interested in participating in the FVC should have his/her attorney contact the FVC Project Coordinator to request an application. Interested veterans may observe court proceedings with no commitment to participate.

## How does the FVC work?

The FVC is a program requiring commitment, strength, honesty, and persistence. Veterans are expected to:

- Attend treatment and other services as recommended
  - Attend recovery/support groups if necessary
  - Appear regularly before the FVC judge for status hearings
  - Complete 16-32 hours of work, school, or volunteer work per week
  - Undergo regular alcohol and other drug testing
  - Maintain sobriety
  - Maintain safe and sober housing
  - Attend meetings with their PO
  - Complete their VA case plan
