COUNT XIII:

That in the First Judicial District, State of Alaska, on or about April 22, 2008, at or near Juneau, ROLAND R MAW with the intent to mislead a public servant in the performance of a duty, submitted a false written or recorded statement which the defendant did not believe to be true on a form bearing notice, authorized by law, that false statements made in it are punishable.

All of which is a Misdemeanor class A offense being contrary to and in violation of 11.56.210(a)(2) and against the peace and dignity of the State of Alaska.

COUNT XIV:

That in the First Judicial District, State of Alaska, on or about October 7, 2010, at or near Juneau, ROLAND R MAW with the intent to mislead a public servant in the performance of a duty, submitted a false written or recorded statement which the defendant did not believe to be true on a form bearing notice, authorized by law, that false statements made in it are punishable.

All of which is a Misdemeanor class A offense being contrary to and in violation of 11.56.210(a)(2) and against the peace and dignity of the State of Alaska.

COUNT XV:

That in the First Judicial District, State of Alaska, on or about May 22, 2013, at or near Juneau, ROLAND R MAW with the intent to mislead a public servant in the performance of a duty, submitted a false written or recorded statement which the defendant did not believe to be true on a form bearing notice, authorized by law, that false statements made in it are punishable.

All of which is a Misdemeanor class A offense being contrary to and in violation of 11.56.210(a)(2) and against the peace and dignity of the State of Alaska.


COUNT XVII:

That in the First Judicial District, State of Alaska, on or about May 20, 2014, at or near Juneau, ROLAND R MAW with the intent to mislead a public servant in the performance of a duty, submitted a false written or recorded statement which the defendant did not believe to be true on a form bearing notice, authorized by law, that false statements made in it are punishable.

All of which is a Misdemeanor class A offense being contrary to and in violation of 11.56.210(a)(2) and against the peace and dignity of the State of Alaska.
