That in the First Judicial District, State of Alaska, on or about January 15, 2009,  
at or near Juneau, ROLAND R MAW, intending to mislead a public servant in the

1 performance of a duty, did knowingly submit a false written or recorded statement in an  
2 application for a permanent fund dividend.

3 All of which is a Felony class C offense being contrary to and in violation of  
4 11.56.205 and against the peace and dignity of the State of Alaska.

6 **COUNT II:**

7 That in the First Judicial District, State of Alaska, on or about October 8, 2009,  
8 at or near Juneau, ROLAND R MAW committed the crime of theft and the value of the  
9 property or services was \$750 or more.

10 All of which is a Felony class C offense being contrary to and in violation of  
11 11.46.130(a)(1) and against the peace and dignity of the State of Alaska.

12 **COUNT III:**

13 That in the First Judicial District, State of Alaska, on or about January 23, 2010,  
14 at or near Juneau, ROLAND R MAW, intending to mislead a public servant in the  
15 performance of a duty, did knowingly submit a false written or recorded statement in an  
16 application for a permanent fund dividend.

All of which is a Felony class C offense being contrary to and in violation of 11.56.205 and against the peace and dignity of the State of Alaska.

COUNT XII:

That in the First Judicial District, State of Alaska, on or about October 2, 2014, at or near Juneau, ROLAND R MAW committed the crime of theft and the value of the property or services was \$750 or more.
