TO FILE PLAINTIFFS' CONSOLIDATED PLEADING**



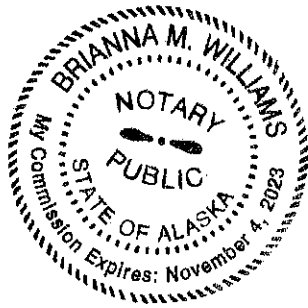
AFFIDAVIT OF KEVIN F. McCOY
