Plaintiffs respectfully request this Court issue its decision on this motion by 12:00 p.m. on Friday, April 24, 2020. Plaintiffs respectfully request the Court issue a decision on the underlying Motion to Characterize Case as Non-Routine and Set Expedited Discovery and August 2020 Trial Date by close of business on Tuesday, April 28, 2020. Plaintiffs balanced the need for a ruling soon to expedite this case to trial in August 2020 with Defendants' right to a reasonable opportunity to respond to both motions.

Expedited consideration is needed on Plaintiffs' Motion to Characterize Case as Non-Routine and Set Expedited Discovery and August 2020 Trial Date because there is not a sufficient window of time between the lieutenant governor's decision on March 17, 2020 to accept the signatures submitted by those circulators of the 19OGTX ballot initiative paid by Advanced Micro Targeting, Inc. to collect signatures to place the initiative on the ballot, and the State's printing of statewide ballots in early September 2020. While this is an issue of first impression in Alaska, many other courts have held that petition circulators' false affidavits invalidate all the signatures in that petition.³ These

cases emphasize that a circulator's false affidavit undermines the integrity of the signatures that circulator has gathered, and that invalidation of all signatures is the appropriate remedy to ensure compliance in the future and the legality of the petition at issue.

As discussed in the principal motion, the State of Alaska has historically printed statewide ballots in early September of the election year. Therefore, there is a little more than four months from the date of this filing for the parties to litigate the merits of this matter, and, if Plaintiffs prove that circulators submitted false affidavits, to invalidate the signatures contained in those circulators' petition booklets and to keep 190GTX on the ballot for lacking sufficient signatures under AS 15.45.140.

Plaintiffs are mindful of the current public health crisis. This motion does not seek any immediate hearings or otherwise to interfere with current stay-at-home orders. However, some immediate action is required by this Court in order to be able to resolve this case by late-August, prior to printing of ballots that is likely to occur in September.
