**ORDER GRANTING RENEWED MOTION FOR EXPEDITED CONSIDERATION (OF  
MOTION TO CHARACTERIZE CASE AS NON-ROUTINE AND SET EXPEDITED  
DISCOVERY AND AUGUST 2020 TRIAL DATE)**

This case was commenced on April 10, 2020. On April 17, 2020, Plaintiffs filed a *Motion for Expedited Consideration of Motion to Characterize Case as Non-Routine and to Set Expedited Discovery and August 2020 Trial Date*. This Court denied Plaintiff's initial Motion for Expedited Consideration noting that not all parties had appeared through counsel. On May 5, 2020, Plaintiffs filed a *Renewed Motion for Expedited Consideration* noting that all parties have now been served and appeared through counsel.

Because this case appears to require an accelerated timetable for resolution, the Court GRANTS Plaintiff's Renewed Motion for Expedited Consideration. Any party wishing to file a written response to the *Motion to Characterize the Case as Non-Routine and Set Expedited Discovery and August 2020 Trial Date* shall do so by Monday May 11, 2020.
