ORDER RE MOTION FOR EXPEDITED CONSIDERATION

This case was commenced on April 10, 2020. On April 17, 2020, Plaintiffs filed a Motion for Expedited Consideration of Motion to Characterize Case as Non-Routine and to Set Expedited Discovery and August 2020 Trial Date. To date, Plaintiffs have not filed proof of service, and only one of the Defendants has appeared through counsel.

Further, on April 3, 2020, the First Updated Presiding Judges' Statewide Administrative Order Governing Relaxation and Suspension of Various Court Rules Based on the COVID-19 Pandemic was issued. The Order suspends all superior court

proceedings through May 31, 2020, with exceptions for priority hearings.¹ A Second Updated Presiding Judges' Statewide Administrative Order Governing Relaxation and Suspension of Various Court Rules Based on the COVID-19 Pandemic was issued on Friday, April 24, 2020. The Second Presiding Judges' Order continues the suspension.

While the Court recognizes that Plaintiffs' Complaint seeks injunctive relief, and Plaintiffs desire an expedited schedule and trial, the Court will not grant expedited consideration before all parties have been served and have a chance to be heard. Accordingly, Plaintiffs' Motion for Expedited Consideration (Case Motion #2) is Denied without prejudice.
